This power enables eligible local councils to do anything which it considers likely to achieve the promotion or improvement of the economic, social or environmental well-being of their area.

# 86. <u>COMMUNITY SERVICES</u>

Councillor Miss K Darby moved the report of the Community Services Committee meeting held on 8 June 2009.

The Town Council was commended for taking the initiative to effect repairs on All Saints' wall, recognising that a lengthy discussion with the various public bodies involved could take several months and that the work was of high priority for the appearance of the church.

The Town Clerk was also able to confirm that the Ministry of Justice had replied to a letter regarding conflicting advice on the management of memorial testing. The Ministry of Justice is now working with ICCM for a joint solution, however in the meantime, the Town Council's policy is to apply visual and hand testing only.

There were concerns that the Council's Grants Policy does not allow places of worship to receive grants, irrespective of that the application may be to enable the building to be used by the wider community. Councillors were advised that they would have the opportunity to amend the Grants Policy wording later in the meeting.
