It was **RESOLVED** that:

The Minutes of the Sub-Committee Meeting held on 4 April 2011 were approved as a correct record of the proceedings, and the Chairman authorised to sign the same.

449. MATTERS ARISING FROM THE MINUTES NOT DEALT WITH ELSEWHERE ON THE AGENDA – PAPER A

Mr Will O'Neill attended the meeting to answer the Committee's queries regarding Hertford Theatre:

Cycle Racks

The Committee was concerned that the cycle racks, when reinstated, should be easily visible preferably to the main entrance/reception desk in order to enhance security. Additionally it was felt that a cover for the racks should be provided. Mr O'Neill stated that a site visit had taken place and the area considered most appropriate was on the hard standing on the edge of the green, very close to the existing racks. He stated that a cover had not been considered largely due to cost and requirements for planning consents given

that the Theatre was located in the Conservation Area. Mr O'Neill stated that he would be happy to meet members on site to discuss an alternative location.

5 Bishops Sculpture

The Committee had for some time been concerned at the positioning of the sculpture and the fact that the interpretation panel was missing. Mr O'Neill confirmed that a new, lower location for the sculpture had been chosen, on the triangular part of the building facing the Templars and that the interpretation panel had been located and would be sited at a readable height close to the sculpture.

Satellite Dish

The Committee was also concerned that a satellite dish had been installed on a visible part of the historic building without permission. Mr O'Neill confirmed that the dish had been installed in the optimum location for a good signal. He agreed to consider suitable alternatives.

Mr O'Neill was thanked for his attendance and he left the meeting.

Sainsburys

An issue of street naming was discussed concerning the road, originally called Station Approach, but latterly renamed Hartham Lane. It was felt that once the Sainsbury development was completed and the original Hartham Lane pedestrianised, there could be confusion for motorists. This matter would be considered at a future meeting.

Note: Cllr Radford declared a prejudicial interest and left the room during the discussion.

Street Naming - Development at Sacombe Road

This was an item for future agenda, but the name Sacombe Road Gardens was tentatively recommended, although it was noted that this could lead to confusion for the postal service with Sacombe Road.
