EHC Planning enforcement officers are in process of contacting the business partner to discuss the matter. 3 Jan 2020 – officers asked for update from EHC.
Development of 'rare breed farm' at the corner of junction Bramfield Road / North Road		N. Kirby	Members have seen construction work of outbuildings in this location, but not seen an appropriate planning application. Officers have written to East Herts Planning and made them aware that the Town Council expressed concern about the development of this piece of land and request that enforcement is carried out as quickly as possible. Update 11-6-19 The enforcement notices have been appealed and EHC are waiting for a planning Inspector to be appointed. As of 19 <sup>th</sup> August 2019.EHC have advised that 'the appeal has been submitted but no start date for the timescale of events, or Officer has been sent through'. Update as of 29 November 2019 from EHC: 'No further correspondence from the Planning Inspectorate. Investigations ongoing and information being collated. Some illegal advertising signage has already been removed by officers.' January 2020: HTC officers have asked for further update.
